If you don't comply with this regulation the exhibition management will demand the removal of the roofing or alternatively the installation of a fire alarm system by the Frankfurt Fair (at the cost of 44€ per square meter). Additionally, all stands must have roofings made of low flammable materials and if the roofing is larger than 30 square meters a fire alarm system by the Frankfurt Fair must be installed (44€ per square meter).
